

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE No. 2

An ordinance levying taxes for all town purposes for Preemption Township,
Mercer County, Illinois, for the tax year 2017 , collectable in 2018.

BE IT ORDAINED by the Board of Trustees of Preemption Township,
Mercer County, Illinois, as follows:

SECTION 1: That the sum of Eighty Four Thousand Four Hundred Fifteen
Dollars (\$84,415.00) are hereby levied upon all
property subject to taxation within the Township as that property is assessed and equalized, in order to
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted
by the people in accordance with the law, for such purposes as:
